OV BUSINESSES RALLY FOR YOUTH AS OV MONARCHS SOCCER RACE FOR THE CURE AT RELAY FOR LIFE

OV Businesses Rally for Youth as OV Monarchs Soccer Race for the Cure at Relay for Life

Orangevale businesses again rally behind the young women of the OV Monarchs soccer team, helping raise \$3,300 for the American Cancer Society in support of their 24-hour run at Relay for Life on October 1st.

“Participating in Relay for Life meant a lot to me,” shares Cameron Miller of the U14 Monarchs. “This was our second year and we had new additions to our team. I was excited for them to see what it was like and how fun it was.” Chloe Scott-Robinson, a fellow team member adds, “It was awesome doing something fun while helping out a good cause!”

With a desire to grow their recreation soccer skills in new environments, the Monarchs started participating in regional tournaments last year. Coach Terry Miller joined with Relay for Life to fundraise for both the American Cancer Society and the team’s tournament fees, while also providing opportunity to mentor community advocacy and involvement.

“It was so very much worth raising money for Relay,” shares C. Miller. “Some family members of our team have had cancer, and it feels really good to do it in honor of them.”

Commending the impact sponsoring businesses have on youth, Patsy McGavock, Monarch parent shares, “I fell in love even more with the Orangevale community last year as I saw so many business owners encourage my daughter Becca, who could hardly read her notes yet within a day in our



community was confidently inviting adults to join her support of those suffering from cancer. I could not give her that experience on my own. I invited it with hope others would support her.” A week later Becca brought 5 teammates with her, leading them in the same opportunity.

“When I see a young person like you come in – my answer is an immediate yes,” Michelle Famestad of Orangevale Copy told B. McGavock before she handed her a sponsorship check. “So often it is the parents, or an email,” she explains. “If the kids are doing the work, it’s important to encourage them. It’s teaching them public awareness and positive impact. I’m proud of them.”

Some sponsors won a special place in the Monarchs heart; Dezy’s Beef, Bread & Beer among them. “One businesses that sponsored me and my team is a place named Dezy’s,” shares C. Miller. “It was so fun. In order to get the sponsorship from him we have to prove ourselves as athletes by doing a whole bunch of exercises.” He then walked into each surround-

ing business challenging them to sponsor, and had booked the Monarchs at an OV Rotary meeting before they left his business. “I cannot express deeply enough the impact these business owners are making,” adds P. McGavock. “Julie King from The Last Tangle Salon not only sponsored but took time to mentor my very hesitant daughter. ‘Can you do one thing,’ she asked. ‘Just smile as you read,’ and Becca’s face lit up. Then she confidently stated how Becca was going to invite so many people to do a good thing, coached her on ways to reach out and referred her to other businesses with a challenge to meet her donation. That was Becca’s spring board.”

One of the most tender moments was with Dawn Williamson of Warehouse Interiors, a top tier sponsor, who was recently diagnosed with cancer when the girls entered her business. “The Monarchs cause touched my heart because of what I’ve gone through,” she recalls a year later, upon sponsoring again. “And I

CAT KILLINGS IN ORANGEVALE

**PUBLIC NOTICE
THE LETTER BELOW
CONTAINS SENSITIVE AND
GRAPHIC DETAILS THAT
CAN BE DISTURBING**

To Whom It May Concern,
A copy of this letter will be sent to the Sacramento District Attorney, Sacramento County Sheriff, Sacramento County Sheriff Internal Affairs, Animal Control Administration, County Supervisor Sue Frost, Senator Alex Padilla, and several media outlets. Names will be redacted for the media copies.

In August, a Folsom resident filed a report with the Sacramento County Sheriff's Department. Report # 22-266668. Her Ring doorbell recorded a young man grabbing her cat. The cat cried, he hit the cat in the head many times, the cry stopped abruptly. The cat was found with a broken neck under the owner's car the next day.

Other people missing cats started going through their Ring videos. Fourteen people have said they have given the Sheriff's Department video of the same young man walking off with their cats. The cats were either found dead or were not seen again.

A report was filed by Orangevale resident (name available upon request) with the Sheriff's Department on 09-2-2022, stating that her cat had gone missing. On the same morning, her other cat was found in her hedges, a leg broken with the bone sticking out. Not any other external injuries.

An Orangevale resident filed a Concerned Citizen's report with the Sheriff's Department, report # 2022-808159, on 0-08-2022.

I have left messages with the Sheriff's Department that have not been returned.

I just spoke with the District

Attorney. They are trying to decide whether to prosecute. They have received information from Sacramento County Sheriff, but nothing from Animal Control.

How can the District Attorney make a decision on whether to prosecute when they are not being given information?

I would like to know that the Sheriff's Department has turned over ALL evidence. Someone with the authority to do so must make sure the District Attorney has all of the facts.

People in our neighborhood are dismayed. The cat body count is piling up. The high school is on high alert. We cannot understand why this was not stopped IMMEDIATELY.

The suspect was filmed breaking a cat's neck. That is a crime. It is illegal NOT to report a crime.

Penal Code 597 PC is the California statute that prohibits animal abuse or cruelty. This is defined as maliciously killing, harming, maiming, or torturing a living animal. The offense can be charged as either a misdemeanor or a felony and carries a sentence of up to 3 years in jail or prison.

When there is a school shooting everyone says, "There were so many signs. Why did no one say anything?"

WE ARE SAYING SOMETHING. We are talking, emailing, calling, writing letters. Not two or three people - there are dozens of us that are trying to get someone, anyone, to DO something. We have considered taking up a collection to hire a private detective.

Why is this person being allowed to run loose, hunting companion animals?

If you are a concerned citizen,

please call the District Attorney at 916-874-6218 and tell them you want case # 22-266668 prosecuted.

As I said, I am redacting names for the media. Anyone can call me at 279-201-8169 for more information, or if you have information.

We are told to give all the information we have to Animal Control, but the District Attorney has yet to hear from Animal Control.

The Sacramento County Sheriff has stated that they do not want to ruin someone's life over a cat.

We are asking that someone step in and oversee this.

From "County" how the county supervisors are elected, local school district and school board are set up and run, what is the difference between sheriff department and police department. They are required to run for office, learn the importance of debate, campaigning for local offices. "city" council, mayor, and other city offices. Then "State government." They run for seats in congress, senate and assembly members, superior court, lieutenant governor and governor. This program is a very comprehensive on hands learning experience. In our local area, American Legion Auxiliary (ALA) Unit 383 of Fair Oaks along with American Legion Post 362 of Folsom sponsored Casa Roble, Bella Vista, Folsom, Vista Del Lago, and Oakridge high schools. Oh, did I mention that the American Legion has a similar program Boys State? They have been sending junior boys for 87 years to their program. The Boys State has been meet-

ing up here in Sacramento for many years at Sacramento State University. 2022 Girls State was moved from a college in southern California to Sacramento and are now also meeting at Sacramento State University.

Last Thursday we held our Boys State and Girls state awards ceremony at the Folsom Veteran's Hall.

Dinner was served to our new Boys and Girls State citizens, along with parents, friend, and some local dignitaries. With the election less than 20 days away, it's important that voters are informed about who is running in local elections.

My name is Tanya Kravchuk and I'm running for San Juan Unified School District, Trustee Area 5.

I'm a small-business owner and a mother of four; I have a child in elementary, middle and high school in the district. My family immigrated to the U.S. from Ukraine in 1990 in search of economic and religious freedom. These values are deeply ingrained in the fabric of our family and the motivation for my decision to run for the school board.

Today's climate has been challenging for parents, students and the community. We've been misled, ignored, and left with far too many questions about our children's education, curriculum, and safety. I see a worldview being pushed that is antithetical to the one America was founded upon.

My #1 priority will be ensuring our schools are safe, free from gangs and drugs - and focused on solid curriculum, not social experiments. I will tackle the learning loss caused by school shutdowns and hold school administrators accountable for student progress and safety.



I will work to strengthen our curriculum to be more focused on academics or vocational training so when students graduate; they are prepared to get a job, enter a trade, or go on to college. And I will ensure the voices of parents and the community are never ignored again.

Finally, I will bring some much-needed accountability to the District. San Juan Unified has a budget of more than 300 million, yet

enrollment continues to decline. The district has issued \$1.5 BILLION in school bonds, yet many of our schools still lack modern facilities and equipment. We need to empower citizen oversight boards and take real action to instill fiscal responsibility in the District.

My professional experience includes working as the Director of Development and Communication for the Children's Receiving Home of Sacramento, where I oversaw cultivation activities and developed partnerships with local businesses and the community to support the program's mission to save children. I have served as VP of our elementary school Site Council, taught Sunday School at church for over 20 years and have been an active member and committee chair for the Rotary Club of Sacramento and the extremely successful Night of Hope benefit concert. I also worked with schools and local governments during the 2020 Census to secure support for an accurate count.

As a mother of children who attend schools in San Juan Unified, I know personally the challenges faced by parents and students. As a Trustee, I will work tirelessly to ensure parent voices are heard and will immediately work with administration to develop robust community partnerships that build trust and support all students. BUTTERFINGER BARS

Crust:

1 cup butter (2 cubes)
1 cup light brown sugar
½ cup granulated sugar
½ tsp vanilla extract
2 large eggs
2 ½ cups all-purpose flour
1 tsp baking soda
½ tsp salt

2 cups Butterfinger candy bars about 15 “fun size” bars, coarsely chopped

Frosting:

¾ cup creamy peanut butter
½ cup butter, softened
½ tsp vanilla extract
1 ½ cups powdered sugar
1-2 TBSP milk
½ cup chopped Butterfinger candy bars, about 4 “fun size” bars-save a handful for sprinkling over the top

Instructions:

- 1.Preheat oven to 350 degrees
- 2.Add butter, and sugars to a mixing bowl and cream together until smooth and light
- 3.Add the vanilla and eggs and mix well
- 4.Add the flour, baking soda and salt and mix on low speed until just combined. Stir in 2 cups chopped Butterfinger bits.
- 5.Smooth mixture into a lightly greased 9x13 inch baking pan. Bake for 24-26 minutes until center of bars is just set and no longer

glossy looking

6.Remove from oven and cool completely before frosting

Frosting:

- 1.With an electric mixer, beat the peanut butter and butter on medium speed until completely smooth. Add vanilla and mix.
- 2.Reduce speed to low and add the remaining ingredients (save a handful of Butterfinger bits to sprinkle over the top after frosting), beating until fully incorporated. Increase the speed to medium high and beat for 1-2 minutes or until light and fluffy.
- 3.Spread the frosting on the bars. Sprinkle the top with the handful of Butterfinger bits.
- 4.Cut bars into 24 pieces.

Notes: Store in an airtight container in the fridge for up to a week. Can be frozen by cooling bars completely, then flash freeze uncovered for 30 minutes. Then wrap tightly in plastic wrap and foil. Freeze for up to a month.

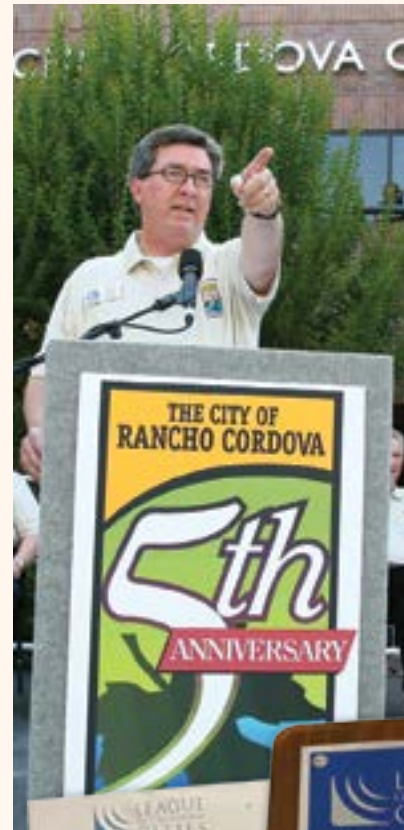

COMPLETE HIGH SPEED RAIL FAILURE

As I come to the close of my sixth year on the Board of Supervisors, I have seen many issues fall and rise in terms of importance for the residents of Sacramento County. For example, homelessness went from an issue that I barely ever received a phone call about when I first entered office, and transformed into one of the biggest issues on most people's minds. But one issue has remained troubling to Sacramento County residents since the day I entered office until now, and that is the deplorable condition of Sacramento County roads.

I fully sympathize with these concerns because I am also upset. My house backs up to Madison Avenue, and every single day that I leave my home I am driving on road conditions that are frankly embarrassing. And due to this, one of the primary questions I receive from people when I speak in my community meetings is "why can't you fix the roads in the County?" I wish it were that simple, because if it were I would have done it years ago. So I want to take this opportunity to explain why it's not so simple, and what we can do to change things.

What many people do not understand is that the vast majority of funds that are spent on local roads are from the state and federal government. Not only that, but many of these funds are competitive dollars, meaning we are only going to win those funds for major projects that have nothing to do with resurfacing, like the road widening happening right now on Hazel Avenue. So even if I wanted to prioritize local road resurfacing, the money Sacramento County could divert towards roads would be insignificantly small compared to what the

state and federal government have the ability to do.

The problem Sacramento County is experi-

encing with our roads is not localized to just our county or even region. This is a problem afflicting the entire State of California, as of last count our state had over \$47.3 billion in road maintenance that has been postponed due to not having enough money for our roads, highways, and bridges (also called deferred maintenance). This enormous deferred maintenance bill would feel more understandable if California was broke, but at the same time we have this bill we are spending outrageous amounts of money on California High-Speed Rail (CAHSR), which in my opinion is only a fraction as important as having reliable roads. CAHSR has the potential to benefit a small fraction of the population, specifically those that would use it to commute. Meanwhile,

roads are used by everyone, including passengers, freight, fire service, police service, etc. To top it off, the train doesn't even come close to Sacramento County, as the furthest north it goes is San Francisco.

When voters approved CAHSR in 2008, it was supposed to cost \$34 billion and be completed by 2020 connecting San Francisco to Los Angeles. Four years ago this price tag had risen to \$79 billion, earlier this year the 2022 draft business plan estimated it would cost \$105 billion, and just three months later the "final plan" raised the estimate to \$113 billion. And not only do these costs continue to rise, but there is still no certainty the complete project will ever get built. Just the Merced to Bakersfield section of the project (which is supposedly the "easiest" section to build) has an earliest competition date of 2029, but this is a date that just keeps getting extended, as four years ago that date was 2024.

Even if we let CAHSR continue to build the central valley line and we abandoned CAHSR after that, we would save enough money to pay for every cent of deferred maintenance for all roads, highways, and bridges in California. The California Legislature and the Governor have the capacity to fix our roads, they just need to change their priorities and focus on what California needs the most.
